LYNDON #2052

Lyndon Elks Lodge #2052 donated its largest amount ever to help fight multiple sclerosis (MS) this year. The Lodge has been an avid supporter of the mission for many years. It's a mission that 2022-2023 Lyndon Elks Member of the Year Britt Weatherby is very passionate about, and his motivation to spearhead a variety of events throughout the year to raise money for the National MS Society. Proceeds benefit research and programs for those living with MS.

On May 11, 2024, Weatherby and his daughter presented a check from Lodge #2052 for \$15,000 to the Society's Indiana-Kentucky-Tennessee chapter at Walk MS Louisville, one of the non-profit's main fundraising events. This topped last year's donation of \$10,000.

Weatherby's fundraising started out with a 50/50 raffle during Lent Friday fish frys at Lodge #2052. He has since expanded his efforts to cooking for Lodge dances, selling his popular ribs and hams for holidays, and providing all the food for the Annual Concert & Car Show at the Lodge. He's championed the cause that's not only important to him but other Lodge members whose lives have been touched by MS.

When Weatherby's daughter was diagnosed in 2008, there were only six medications available. There are now more than two dozen treatment options thanks to research made possible through funding and donations. Lyndon Elks Lodge #2052 is proud to be a part of moving us one step closer to finding a cure for MS!



MIDDLESBORO #119

Middlesboro received their city charter on March 14, 1890. Less than 8 months later, on Nov. 6, 1890, Middlesboro Elks Lodge received their charter from the Elks Grand Lodge, thus making the Middlesboro Elks almost as old as the city itself.

A large delegation of Elks from both Louisville and Knoxville lodges traveled by rail to Middlesboro for the occasion. Chosen to be the first Exalted Ruler (President) of the lodge was none other than Middlesboro's founding father, Alexander A. Arthur, who had been instrumental in the Elks organizing in Middlesboro. Middlesboro's local newspaper of the time published the following account in their Nov. 7, 1890, edition: "Middlesborough Lodge No. 119 B.P.O.E. was instituted last night in one of the large rooms at the Middlesborough Hotel. Quite a number of visitors from Louisville Lodge and Knoxville Lodge assisted in the ceremonies. After the institution a banquet and social session was held, and the exercises did not come to a close until 2:15 a.m. It was a thoroughly delightful occasion and was highly enjoyed by both visitors and citizens."

However, by 1893 Middlesboro entered a period of decline, or "bust", caused by several factors including the general financial Panic of 1893 which affected the whole country. Middlesboro's population declined, the American Association went into receivership and many Middlesboro organizations and businesses failed. The Elks Lodge was not immune to this "bust" and sometime in 1894 the lodge was disbanded.

But by 1906 Middlesboro had rebounded and the city entered another period of prosperity, thanks largely to the coal and timber industries. On July 6, 1906, again with much fanfare, the Elks was reorganized in Middlesboro and received their new charter, but with a new number, Lodge #1041. In 1912 the Elks Grand Lodge restored the original charter number to the Middlesboro Lodge, that being #119.

A catalyst in reorganizing the Elks in Middlesboro and the first Exalted Ruler of the newly formed lodge was a prominent businessman and politician of the time, Kentucky State Representative Joseph F. Bosworth, who would later serve two terms as State Senator, then back to the House of Representatives. Well-known and respected state-wide and known in Kentucky political circles as the "father of good roads", in 1920, he was elected by his Republican peers as Speaker of the House, serving in that capacity for two years until Republicans lost their majority. He was the last Republican to serve as Speaker of the House for almost 100 years, until 2017. He was serving as a Trustee of the Middlesboro Lodge at the time of his death in 1941. Although he is now mostly forgotten, the Elks were pleased they could "bask in his reflected glory" during his years in the state legislature.

The first place the new lodge could call their own was a four-story building on the north side of Cumberland Ave. between 20th and 21st street. This building was erected for the Elks in 1911. It contained a gymnasium, restaurant, bowling alley, and rooms for use by the public. During the influenza epidemic of 1918, the Elks turned the building over to local doctors to be used as a charity hospital. Although the Elks intended this to be their permanent home, due to financial difficulties after World War 1, in

1921 the mortgage on the building was foreclosed. Doctors Brosheer and Brummett then purchased the building, and it was used as The Middlesboro Hospital for many years until the late 1950's. This building still stands today in downtown Middlesboro but is in very poor condition and is slated for demolition. Although the Elks owned it for only 10 years until 1921. it is still referred to by some locals and the media as "The Elks Home".

Still active in Middlesboro, Lodge #119 is the second oldest lodge in Kentucky, behind only Louisville Lodge #8, and is ranked 119th in age among the nearly 2,900 lodges chartered in the country since the Elks founding in 1867.

The lodge began a trust fund for the center in 1994, and has made a multitude of investments prior to giving full access to the fund to the center.

The Marshall County Association for Exceptional Children and Adults was established in 1963 by a group of concerned parents looking to provide opportunities for their children with mental and developmental disabilities.

The program began as a way to offer education to disabled children, but shifted to providing adult care after disabled children began to be offered accommodations in public schools.

At the time of signing over, the fund held just over \$125,000.

Styers made sure to state that the Elks Lodge will continue to hold their annual golf tournament a for the center. The 2024 tournament is scheduled for September 14. Exceptional Center Board Chairman LoAnne Peck accepted the donation on the center's behalf.


